Dear Parents,

In my classroom your child will be working with several programs on and offline. In order to properly gain access to many of the online programs, which we will be using, your student will need to set up a G-mail account. Your student's G-mail account will also act as an effective and efficient way to improve communication between students and myself. The primary purpose of this e-mail is to support teaching and learning.

These accounts will be used in my classroom for curriculum related projects but may be used outside of school for personal e-mail by students with their parent's permission. I would like all students to create a g-mail account to build uniformity, access and consistency in the classroom. Before creating a G-mail account I will review with your student e-mail etiquette, prohibited conduct, how to properly maintain their g-mail account and the best practices when utilizing their account.

In addition to granting your child permission to create a G-mail account I would also like your permission to be able to post your student's work on www.misscoburn.com and various web-hosting sites. Lastly, I highly recommend your student purchase a 2 gb flash drive (approximately, \$5.00.) This device will provide your student a safe and secure way to back up work in the class.
